

**FS CURRICULUM COMMITTEE  
REPORT – MAY 5, 2011**

Members of the Curriculum Committee were asked to consider several proposals from two departments:

**Department of Information Systems and Management Technology**

Proposal 1. Minor in Digital Forensics

**Minor in Digital Forensics**

The Minor in Digital Forensics is open to all majors in the University. A student majoring in Information Systems will be required to take 18 semester credit hours of coursework. Other majors may be required to take additional hours depending on their academic background.

A. The following courses are required:

IS	3513	Information Assurance and Security
IS	3523	Intrusion Detection and Incident Response
IS	4483	Digital Forensic Analysis I
IS	4523	Digital Forensic Analysis II
IS	3533	Cyber Law

Proposal 2. Minor in Network and Data Center Management

**Minor in Network and Data Center Management**

The Minor in Network and Data Center Management is open to all majors in the University. A student majoring in Information Systems or Infrastructure Assurance will be required to take 21 semester credit hours of coursework. Other majors may be required to take additional hours depending on their academic background.

A. The following courses are required:

IS	3453	Networking Fundamentals
IS	3513	Information Assurance and Security
IS	3523	Intrusion Detection and Incident Response
IS	4033	Network Operations
IS	4213	Power and Air Conditioning
IS	4223	Emerging Network Technologies
MOT	4143	Introduction to Project Management

To declare a Minor in Network and Data Center Management, obtain advice or seek approval of course substitutions for course requirements, students must consult with the College of Business Undergraduate Advising Center.

The Committee reviewed the proposals provided by the Department and the Office of Undergraduate Studies Memorandum (Appendix A).

There are seventeen members on the Curriculum Committee. The majority of the FS Curriculum Committee members voted to approve both minors. The vote tally: 15 voted to approve the minors and 2 abstained.

## **Department of Finance**

### Proposal 1. Minor in Real Estate

#### **Minor in Real Estate**

The Minor in Real Estate is available to students pursuing a B.B.A. degree. All students pursuing the Minor in Real Estate must complete 19 semester credit hours of coursework.

A. 7 semester credit hours of required courses:

FIN	3014	Principles of Business Finance
RFD	3433	Principles of Real Estate

B. 12 additional semester credit hours of real estate courses

To declare a Minor in Real Estate, obtain advice, students should obtain advice from the College of Business Undergraduate Advising Center

### Proposal 2. Name Change of a Minor

The Department requested that the name of a current minor be changed from Minor in Facility Management to Minor in Facility and Property Management since the program addresses both facility and property management.

### Proposal 3. Change Prefix on Courses

The Department requested that the prefix on real estate finance and development courses be changed from FIN to REFD.

The Committee reviewed the proposals provided by the Department and the Office of Undergraduate Studies Memorandum (Appendix B).

There are seventeen members on the Curriculum Committee. The majority of the FS Curriculum Committee members voted to approve the minor and the name change and prefix changes. The vote tally: 14 voted to approve the minor and changes and 3 abstained.

**Be it resolved that the change in name of the Minor in Facility Management be changed to Minor in Facility and Property Management be approved.**

**Be it resolved that the change in prefix from FIN to REFD be approved.**
