# Students dropped for unpaid balances?

- Students will not automatically be dropped due to late financial aid.
  - If aid has been “Memo’d” or “Authorized” in Banner by Financial Aid Department
  - If aid not yet authorized in Banner (e.g., if student submits paperwork late), but Financial Aid confirms that aid will be approved.
- Financial services also offers Tuition and Fee loans that will defer payment for students for 90 days.
  - If the delay due to Financial Aid or other related offices, possible to remove interest.
- Installment payments possible.
- But cannot allow students to simply accumulate increasing unpaid balances.

# HOP 2.11 (Annual Review of Faculty)

- Discussed in Senate meeting, Nov. 8, 2012
- Issues returned to committee:
  - Specification of time period to include
    - EMRW recommended no change be made
  - EMRW recommended removal of disqualification for merit if “unsatisfactory” in any one area.
    - Senate electronic vote: 29 in favor, 2 opposed
- Senate recommendations forwarded prior to Dec. 3, 2012 deadline

## HOP 2.11 and 2.22: Stakeholder Review Complete

- HOP 2.11 and HOP 2.22 (CPE)
  - University HOP committee, Dec. 11, 2012
- Senate recommendations included, except for minor change (in HOP 2.11) in minimum scores and rounding to nearest thousandth (instead of tenth):
  - Exceeds: 3.5 to 5 (no change)
  - Meets: 2.0 to 3.499 (instead of 2.0 to 3.4)
  - Fails: 1.0 to 1.999 (instead of 1 to 1.9)
  - Unsat.: 0 to .999 (instead of 0 to .9)
